- NAAC Accreditation results were announced on 02-11-2018 and SVEC secured 2.95 CGPA points on a scale of 4.0 with B++ Grade.
- AQAR for the academic year 2017-18 was planned to be submitted to NAAC.
- As part of new AQAR submission guidelines, IQAC Coordinator prepared and presented a New Data Collection format for submission of AQAR for the year 2018-19.

Item 2 : Dean, Academics requested Chairperson, IQAC to initiate the revision of curriculum as per new AICTE-2018 Model curriculum. Chairperson advised the members to understand the essence of new curriculum changes suggested by AICTE and thoroughly revise by incorporating all the necessary components.

Item 3 : During the discussion, it was also suggested to take into consideration of AICTE Examination reforms. Chairperson requested Dean, Academics to ensure that the departments thoroughly understand the process as per the new reforms at the earliest.

Chairperson insisted the need for mandating the MOOC course based learning among faculty and students. Dr.I.Sudarsan Kumar, member of IQAC, insisted on the need for taking up Competency based curriculum keeping in view of changing industry requirements.

Item 4 : Dr.DVS Bhagavanulu, Director, SVEC insisted that Research centers shall prepare an annual report on its functioning and submit them before 28-02-2019.

Director, SVEC informed about the procurement of plagiarism checking software Turnitin procured by SVEC and it was suggested to be mandated that all Research publications be checked for similarity before submission to journals/conferences.

Item 5 : Director, SVEC requested the Chairperson IQAC to take into account of new AICTE regulations for infrastructure and then plan for the next coming academic year accordingly.

Item 6 : It was informed to the members during the meeting that SVEC was listed in NAE-website, USA for getting selected to participate in Grand Challenges Scholars Program.

Chairperson, IQAC insisted departments to collaborate with Professional bodies for enhanced interactions.

Director, SVEC informed about the visit by Experts from Northern Illinois University to the campus during January-February, 2019.

Item 7 : SVEC was accredited by NAAC with B++ grade with 2.95 CGPA on a scale of FOUR. Chairman, IQAC summarized on the appeal process submitted by SVEC on 28.11.2018 as per NAAC guidelines for an improved grade by taking into account of both Qualitative and Quantitative metrics.

It was decided to include Heads of the departments in IQAC and strengthen its functioning.

Item 8 : Coordinator, IQAC presented on Best practices document as suggested by AICTE.. Chairperson instructed the members to initiate the activities accordingly. Dr.I.Sudarsan Kumar, Director(Q&D) presented the Quality Indicator Framework prepared for compliance to contemporary regulations. He requested Chairman, IQAC to ensure that compliance report be prepared and submitted by the departments on the same.

Item 9 : Chairperson, IQAC suggested Dean Academics to organize a workshop on contemporary practices in Curriculum Design and development by identifying resource persons from premiere institutions.

Chairperson, IQAC informed that I2E - Venture Development Center at SVEC is to be launched in collaboration with Northeastern University, Boston, USA and Andhra Pradesh Skill Development Corporation (APSSDC) very soon.
