Minutes of the Meeting

- Item 1 : IQAC Coordinator appraised the activities envisaged under IQAC since its Twenty Second meeting on 22-12-2019 and Chairperson requested the members to approve minutes of its previous meeting. The following are the action taken correspondingly.
 - A Program on Outcome Based Education was organized on 28-03-2019 for Heads, Chairman(BoS) and program coordinators of the departments.
 - Annual reports were prepared by research centers and it was inaugurated by Hon'ble Chairman, SVET on 19-03-2019.
 - Prof. Abdul K.M. Azad from Northern Illinois University visited SVEC for collaborations on 06-02-2019.
 - Heads of the Departments, Deans and Directors were invited as special invitees for the 23rd IQAC meeting.
 - Appeal by SVEC to NAAC for better grade was accepted.
- Item 2 : Dean (Academics) refreshed the members about the AICTE Model curriculum, APSCHE & JNTUA revision of curriculum for the next regulations. He also elaborated on Experiential learning through exhaustive list of lab courses, new components introduced in programs like socially relevant projects, Internship, Minor & Honor Degree courses. Introduction of evaluation mechanism as suggested by AICTE Examination reforms was discussed. Members appreciated the initiatives undertaken in the curriculum design and suggestions were made by the members on internship for students.

- Item 3: The initiatives undertaken in the departments for developing a contemporary curriculum was elucidated by the Chairman, IQAC. Members suggested for internships during the course of study. Mr.K.Kalyan Chakravarthy, member IQAC advised for a minimum of Six Weeks of internship. Dean IIIC illustrated opportunities for internships for students. Inplant training undertaken by Dept. of EEE was cited as an example during the meeting. Dean(TAP) presented the concept of new recruitment strategiesfollowed by MNCs through Hackathons.
- Item 4 : Dr.DVS Bhagavanulu, Director, SVEC discussed on the process being followed to cope-with for the upcoming infrastructure requirements. He discussed on the THREE year plan being submitted by the departments in the month of May, 2019 which includes infrastructure for teaching-learning and research. Changes in the appraisal mechanism for enhancing research were also discussed in the meeting.
- Item 5: Submission of department budget for the academic year 2019-20 was discussed in detail.
- Item 6: Dean(TAP) elaborated on the different in-campus training programs offered for higher education aspirants. The training programs include preparations for IAS, GATE, GRE, IELTS etc... He also discussed on the placement training for III Year B.Tech students during summer vacation.

Alumni contact collection mechanism through Social Media and Batch coordinator was suggested by Ms.Neeraja, Member of IQAC and it was appreciated by the members.

- Item 7: Status of Appeal to NAAC was explained by Chairman, SVEC. It was planned to apply for accreditation of B.Tech(EEE), B.Tech(CSSE), B.Tech(CE) and B.Tech(ME) programs by NBA. AICTE Approval of Existing programs and on supernumerary seats for PIO(B.Tech & M.Tech) was also discussed during the meeting.
- Item 8: Coordinator, IQAC presented on the practices introduced by IQAC like Coding Club, Procurement policy and OBE assessment, they were appreciated by the members.
- Item 9: Student feedback on existing practices in teaching-learning were discussed during student representative interaction. Mr.Jagan Mohan, Member of IQAC cited on Accenture Research laboratory and requested chairman, IQAC to encourage faculty and students to visit the same. IQAC Members congratulated faculty members, students and other stakeholders for AIR 167 in NIRF for SVEC.
