1.0 Action Taken Report on Minutes of 22nd Governing Body Meeting held on 04th January, 2019.

2.0 Report of the Principal for the academic year 2018-2019

2.1 Admissions

Members of Governing Body congratulated the Management and the Principal on admitting students against for almost all the sanctioned intake in Diploma, B.Tech, M.Tech and MCA courses for the academic year 2018-2019.

Also appreciations were made for admitting 45 foreign students into B.Tech & M.Tech Courses under supernumerary quota for PIO.

Efforts taken to establish global linkages for International Students Affairs were noted.

2.2 Academic Performance of students

The members congratulated the Management and the teaching faculty on achieving excellent results in B.Tech, M.Tech and MCA courses.

Institutional Endowment Gold medals presented to the toppers was appreciated by the Members.

2.3 Co-curricular Activities

The members suggested that various student activities may be continued and new student chapters & clubs be established. 3.0 Research
