1. Action Taken Report on minutes / resolutions of 10th BoS Meeting

The Chairman, BoS Dr. T. Nageswara Prasad presented the report on the action taken on resolutions of previous BoS meeting held on 11th June 2019. (Annexure-I). After deliberations the members ratified the report.

2. Report on implementation of Autonomy with respect to syllabi and Regulations (SVEC-19 I-I, I-II of M.Tech(EPS))

The Chairman BoS presented a report on implementation of autonomy pertaining to I-I ,I-II M.Tech.(EPS) for the students admitted in the AY 2019-2020. (Annexure-II) The members of the BoS were appraised the feedback of the students and the faculty on the courses of I, II Semester of M.Tech.
