21 The Management shall ensure the non-availability of carbonated beverages and junk foods around 200 meters of the premises.

22 The Management shall not allow the sale of tobacco products in the premises of the College and the same is prohibited.

23 The Management shall take measures to safeguard the interests of the students without any prejudice to their caste, creed, religion, language, ethnicity, gender and disability.

24 The Management shall get the College accreditated by the State The Mar 30, 2021 15.32,35 IST agencies, after passing out of two batches or six years whichever is earlier, if the College has not acc

25 The management of the College shall not affiliate itself to any University outside the State of Andhra Pradesh and run the courses of other State University in their premises under Section 21-A of A.P. Education Act 1982, failing which, the Managements shall face criminal action under Section 21-A of AP Education Act.

It is to bring to your notice that as per the directions of the State Government to maintain quality in Professional courses and also to avoid unethical practices, the Standing Committee for Affiliation has finalized the M.Tech. course affiliations duly following the guidelines of the AICTE as well as the State Government. The guidelines adopted for finalization of affiliation to M.Tech courses are as follows:

1. AICTE norms, according to which atleast one Professor / Associate Professor (with Ph.D qualification) is available in the concerned department offering M.Tech. programs.

2. The University has got the data that has been provided at the time of FFC inspection. Also the Ph.D holders data is obtained from the affiliated colleges separately. It is found that several names are shown and claimed as present on the day of FFC inspection by several colleges. This is a highly unethical practice and all such names are excluded for consideration.

3. Separate action will be initiated against those faculty who have given their names to multiple colleges and also against the colleges for unethical practices, leading to the deterioration of quality of education.

4. If one eligible Ph.D holder is available in any discipline 18 seats are permitted; if 2 are available 24 or 36 seats are permitted as per the ceiling given by AICTE. If there are two M.Tech. programs in a particular discipline, for example, DECS and VLSI in ECE department, if 2 Ph.D holders are available in the department, each program is given 18 seats or the number requested by the college if it is less than 18.

Accordingly, the following are the M.Tech. courses permitted in your college for affiliation for the academic year 2019-20 with the number of seats mentioned against them.

However, incase of Autonomous colleges and those colleges having M.Tech courses under permanent affiliation, there is no change.




