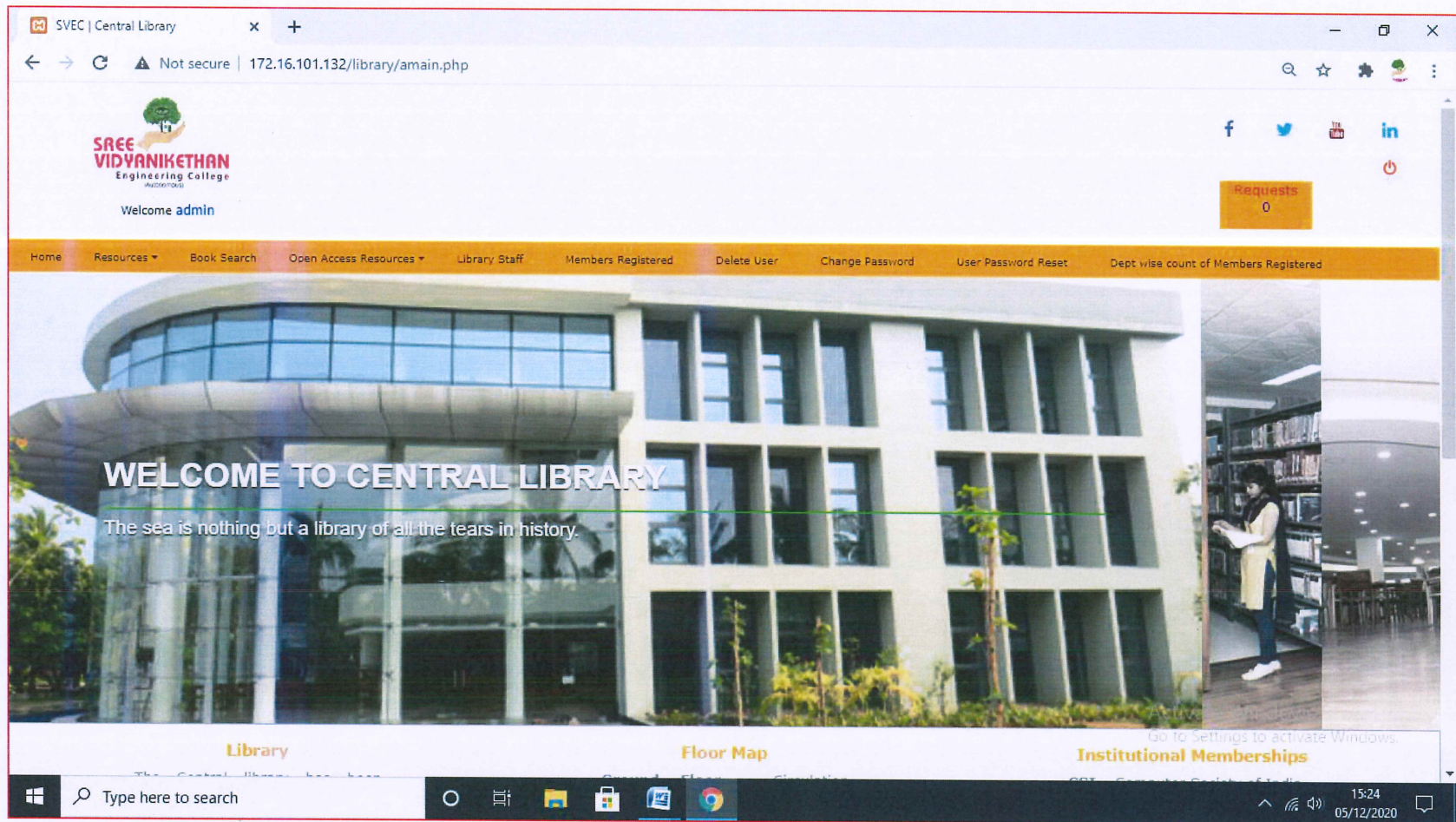
Web page of e-resource Remote Access link to Central Library –Step 2
