



  - c. Your service certificates and relieving letter from last organization.
3. You will be on probation for a period of **12** months from your date of employment. Or such extended period as may be decided by Sree Vidyanikethan Engineering College based on your performance during the probation period.
4. On Satisfactory Completion of your probation period, including that of extended period if any, you will be confirmed in the services of Sree Vidyanikethan Engineering College in writing.
5. The period of notice or salary in lieu of notice in event of resignation or termination of this employment agreement by either party shall be:
  - a. One (1) month during the period of probation; and
  - b. Three (3) months after confirmation of employment.
6. On confirmation of your services, you will be entitled to benefits as applicable to permanent employees.
7. Any absence from work without permission will be deemed to be unauthorized absenteeism and will be dealt with seriously.
8. You shall retire from the services of Sree Vidyanikethan Engineering College on the attainment of 58 years of age.
