- Basic amenities like toilets, parking, hostel, common room, canteen etc. must be provided as
- Separate Hostel facilities should be provided to Boys & Girls.

## LIBRARY, LABS AND WORKSHOPS

- Adequate Library space must be provided and it should be augumented as per AICTE norms.
- Adequate facilities in Labs, Library, classrooms and workshop must be provided as per norms.

Internet facilities should be provided to the students.

Labs ,Library and Workshops to be modernized and to be better equipped as per requirements of AICTE norms.

Special emphasis should be given on industrial institution interaction and training and placement cell should be strengthened
