The specific deficiencies for not granting the other proposed increase / variation in intake / additional courses to the institution are mentioned below:

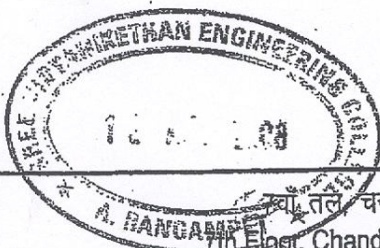




