## **Working collaboration with external Hospitals/Clinics**

The Mohan Babu University (MBU) is being promoted by Sree Vidyanikethan Educational Trust (SVET). The SVET has collaboration with Employees' State Insurance Corporation (ESIC), a premier organization providing Social Security to workforce in the form of Medical and Cash Benefits in the contingencies of Sickness, Maternity, Disablement or death due to employment injury.

The SVET contributes to the monthly membership fee for its employees to avail the benefits extended by the ESIC. The MBU also pays the insurance for its students to avail cash-less medical treatment at the super specialty hospitals.

In addition to this, the SVET has Health/Medical Centre on Campus to treat the student/staff patients. The emergency cases will be shifted to the Primary Health Center (5.0 KM away from the campus) / Super specialty Hospitals in Tiruapti (15.0 KM away from the campus) with ambulance facility available 24X7.

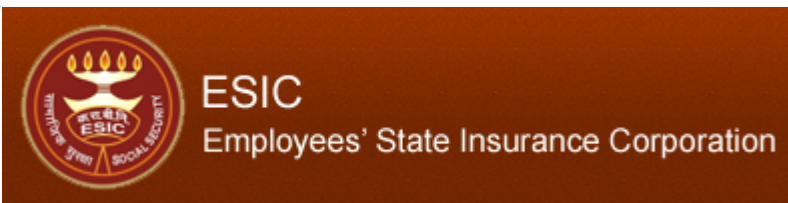
